## **ADMISSION RULES**

1. Students placed under compartment in 10+2 class will not be admitted to 1<sup>st</sup> year of BA, B.Com. and B.Sc, BBA, BCA.
2. If a student has a gap period of one year or more in studies he/ she shall have to furnish in writing an affidavit duly attested by the 1<sup>st</sup> Class Magistrate, the proof of his/ her activities during the gap period .No admission is to be made merely on the basis of an affidavit. Conclusive proof would be required for condoning gap years. Such a student has to furnish character certificate from 1<sup>st</sup>Class magistrate at the time of admission.
3. Any candidate seeking admission on wrong information in respect of age, subjects and %age of marks, his /her admission shall be cancelled at any time when it comes to the notice of the University/ College. Please note that ultimate authority for accepting the admission of student is HP University, Shimla.
4. Total % age of reserved seats in case of S.C./S.T. will be 22.5% i.e. 15 % for S.C. & 7.5% for S.T. If seats remain vacant, the same will be offered to the candidates who have passed the qualifying examination in order of merit. Percentage of reservation of seats for the purpose of seeking admission for disabled students has been extended from 3% to 5%.
5. A concession of 5% marks will be given to the scheduled caste and scheduled tribe candidates.
6. Failed Students of other institution will not be admitted to any class.
7. A candidate who has been expelled or rusticated anywhere shall not be admitted in the college.
8. All admissions shall be strictly provisional and subject to the rules /ordinances of the H.P. University. The college shall not be responsible for the cancellation of the admission / candidature of any student admitted to the college and fee will not be refunded.
9. Not with standing anything contained in the foregoing rules, a student shall be refused admission if his/ her conduct during any previous year in the college/ school has been unsatisfactory.
10. The Principal reserves the right to refuse/ terminate any admission without assigning any reason.
11. Parents must sign the declaration attached with the admission form.
12. Separate University enrollment/ registration form must be filled by the students seeking fresh admission to B.A.,B.Com.,/B Sc., BBA and BCA Part-1.
13. Minimum percentage required for admission in B.A. 1<sup>st</sup> Year is 35%, in B.Com. 1<sup>st</sup>Year is 40% & in B.Sc. 1<sup>st</sup> Year is 45%.

4. H.P. Bonafide Certificate (for Girls only)

8. Migration certificate from Board/ University if the candidate comes from outside the state of Himachal Pradesh

**Note: Students are required to produce original certificates at the time of verification of documents with the admission committee.**

For admission to Under Graduate Courses, the upper age limit is 23 years for general category and 26 years for SC/ST on 1st July of concerned year. The relaxation in age will be accorded as per HPU norms.

### **RESERVATION (Common for B.A./B.Sc./B.Com /BBA/BCA Admissions)**

As per H.P. University rules, 75% seats will be filled out of the candidates who have passed their +2 examination from the schools situated in Himachal Pradesh irrespective of the board. Remaining 25% seats will be filled on All India Basis. Other reservation of H.P. University shall be applicable. However, the seats can be offered to the other candidates, if candidates from Himachal are not available.

### **B.A. 1st Year**

Students seeking admission to 1st year of three year BA Degree course shall have to choose any one combination out of the options given below:-

Subjects for B.A. 1st Year

1. English, Hindi, Environment Science (Compulsory)
2. Hindi/Sanskrit (AECC)

In addition to compulsory English and Hindi, students will have to opt for any two of the following Elective subjects (Major):-

History, Political Science, Music, Hindi, Sanskrit, Economics, and Math's and English.

Note: 1 .Math's is available only with Economics.

2. Students can choose only one out of Music and Sanskrit.



## **B.Sc. 1st Year**

Students seeking admission to 1st year of 3year B.Sc. Degree shall have to opt for the following

B. Sc. (Non- Medical): Physics, Chemistry, Math, English (Compulsory)

B. Sc. (Medical): Chemistry, Botany, Zoology, English

## **B.Com. 1st Year**

### **Compulsory Subjects for B.Com 1st Year**

- 1) Environment Science
- 2) Financial Accounting
- 3) Business Organization and Management
- 4) English (Compulsory)

### **Students must note carefully that:**

- 1) Number of seats in B .Com.-1<sup>st</sup>Year is limited students are advised to fill their applications forms well in time.
- 2) Admission shall be made strictly according to merit list to be prepared on the basis of marks obtained in XII class examination.

## **DEPARTMENT OF BUSINESS ADMINISTRATION (B.B.A Course)**

**No. of Seats: 60**

### **Admission Criteria**

Admission shall be made purely on the basis of academic merit i.e. the marks secured by the candidate in 10+2 examination.

### **ELIGIBILITY CONDITIONS**

Students who have passed / appeared in 10+2 or an equivalent examination securing minimum 45% Marks for general category (40%) in case of SC/ ST ) in aggregate of total marks from any university. Board, Council recognized by law in India shall be eligible to apply for admission.

a) No student who has crossed the age of 21 years / 23 years for girls as on 1st July of the relevant year will be allowed admission to B.B A. However the Vice-Chancellor H.P. University has the power to relax upper age limit by 3 months on the recommendation of the Principal.

- a) The upper age limit is relax able by 3 years incase SC/ST candidates.

### **DRESS CODE COMMON TO BOTH BOYS & GIRLS**

It is compulsory for all students to wear prescribed College uniform on Monday, Tuesday, Friday, Saturday and on other occasions. The uniform prescribed by the college is as: Light Sky Blue Shirt & Black Pants, Neck Tie Maroon Colour, Sweater Light Grey (in winter), Black shoes & Sky blue Socks.

### **DEPARTMENT OF COMPUTER SCIENCE**

**(BCA Course)**

**No. of Seats: 120**

#### **Admission Criteria**

Admission shall be made purely on the basis of academic merit i.e. the marks secured by the candidate in 10+2 examination.

### **ELIGIBILITY CONDITIONS**

Students who have passed / appeared in 10+2 or an equivalent examination securing minimum 40% Marks for general category (35%) in case of SC/ST) in aggregate of total marks from any university. Board, Council recognized by law in India shall be eligible to apply for admission.

- a) No student who has crossed the age of 21 years / 23 years for girls as on 1<sup>st</sup> July of the relevant year will be allowed admission to BCA. However the Vice Chancellor H.P. University has the power to relax upper age limit by 3months on the recommendation of the Principal.
- b) The upper age limit is relax able by 3 years in case SC/ST candidates.

### **DRESS CODE (Common to Both Boys & Girls)**

It is compulsory for all students to wear prescribed College uniform on Monday, Tuesday, Friday, Saturday and on other occasions. The uniform prescribed by the college is as under. Light Sky Shirt & Black Pants, Neck Tie Mehroon Colour, Sweater Light Grey (In Winter), Black shoes, & Sky Blue socks.

### **Post Graduate Diploma in Computer Applications (PGDCA)**

**No. of Seats: 60**

Admission to P.G.D.C.A.: P.G.D.C.A., a one year course affiliated to H.P.U. Shimla, was started from the

Academic Session 2012-13.

**BASIS OF ADMISSION:**-The basis of admission to the PGDCA shall be on merit basis which will be determined on the basis of qualifying examination.

**ELIGIBILITY:**-Bachelor Degree in any discipline with minimum 50% marks.

**AGE LIMIT:** -26 years, as on 1<sup>st</sup>July, of the year concerned provided that upper age limit will be raised by three years for students who belong to SC and ST.

## **DEPARTMENT OF COMMERCE**

### **Master of Commerce (M. Com)**

**No. of Seats: 60**

Master of Commerce ([M.Com](#)) classes with specialization in Finance course is run by the college From the session 1997-98.

**Duration:** This course is spread over four semesters and is of two years duration. There shall be an examination at the end of each semester as per schedule announced by H.P. University, Shimla.

**Eligibility:** [B.Com./B.Com](#), (Hons.) or Bachelor's Degree in Business Administration or B.A. with Commerce or M.A. /M.Sc. in Economics/Statistics/Mathematics with 50% marks.

**OR**

B.A/B.Sc. degree with Economics/Statistics/Mathematics and 50% marks in aggregate.

## **DEPARTMENT OF MATHEMATICS**

### **Master of Science in Mathematics (M.Sc. Mathematics)**

**No. of Seats: 45**

**Duration:**The duration of M.Sc. (Mathematics) courses is two years spread over four semesters.

**Eligibility :** Bachelor's degree of a university established by law in India (with Math as one of the subjects) in 1<sup>st</sup> division with at least 45% marks (40% in case of SC/ST candidate) or honors in the subject on Math.

## **Admission Criteria for M. Com. & M.Sc. (Mathematics)**

As per HP University norms.

### **Age Limit for M. Com. & M.Sc. (Mathematics)**

For Post Graduate Courses upper age limit is 26 years for boys, 28 years for girls and 29 years for SC/ST as on 1st July of the concerned year.

The relaxation in age will be accorded as per HPU norms.

### **DEPARTMENT OF EDUCATION (B. Ed. Course)**

**No. of Seats: 100**

**Procedure for Admission: Entrance test and Counseling to be conducted by HP University Shimla.**

**Eligibility and Educational Qualification:** as per HP University norms.

**RESERVATION:** As per H.P. Govt. /H.P.U. Norms

### **DURATION OF THE COURSE**

**The duration of the B.Ed. (Bachelor of Education) Course shall be of two academic years spread over four semester.**

### **DOCUMENTS TO BE ATTACHED WITH APPLICATION**

- 1) Copy of Matriculation Certificate as proof of age.
- 2) Copy of +2 Certificates.
- 3) Copy of B.A./B.Sc./B.Com. Final Exam.
- 4) Character Certificate issued by Head of the Institution last attended.
- 5) Latest Himachal bonafide certificate, where applicable.
- 6) Proof for claim of Reserve seat.
- 7) Fee deposit receipt at the time of counseling.
- 8) 4 Copies of Passport size photograph.
- 9) Migration certificate, if applicable.
- 10) Copy of Aadhar Card.

### **College Rules**

1. The Principal shall have full powers in all matters pertaining to the admission, promotion, detention of student, imposition of fine & readmission thereof. He/She shall be empowered to take disciplinary action and impose penalties as provided under the University rules.
2. The authority of the Principal extends over all the students at all times or outside the college. If in his

opinion a student acts in an undesirable manner he/she may be asked to leave the college without assigning any reason and if he/she fails to do so within the prescribed time. The principal may, at his discretion, remove his/her name from the college rolls.

- 3 All the students of the college shall abide by the rules of the college existing at the time of admission or as framed from time to time. Defaulters may be punished and punishment may lead to warning, fine, expulsion or rustication from the college according to the nature and gravity of an offence.
4. a) If a candidate is found indulging in ragging (Ragging means and includes any type of physical or mental torture done by any individual or group either by words or by conduct directly or indirectly), the competent authority shall expel the guilty student from the college.  
b) The student shall give in writing an undertaking in this regard at the time of admission.  
c) The H.P. Govt, has declared ragging as cognizable offence and can attract fine, imprisonment or both.
5. **Leave-** No student can proceed on long leave. 75% attendance in each subject is compulsory during the session by every student. Medical leave will be sanctioned on the production of medical certificate from C.M.O.
6. **Absentees-** Continuous absence for seven days will result in cancellation of admission. If any candidate falls short of attendance he/she will not be eligible to appear in the final examination.

#### **DRESS CODE COMMON TO BOTH BOYS & GIRLS**

7. It is compulsory for all students to wear prescribed College uniform on Assembly days and on other occasions. The uniform prescribed by the college is as under.

**Color:** -Pink Suit and Pink Dupatta (Girls)

White Shirt and Black Pants (Boys)

Black Sweater (winter)

Black Shoes

#### **RULES FOR HOUSE EXAMINATION**

1. The college shall hold one mid-term Exam During each Semester & two mid-term exams, during the academic Year

2. It's compulsory for the students to appear in the mid-term Exams.
3. Permission for leave from examination/test will be granted by the Principal only in case of serious illness if the application of the students is supported by a medical certificate and signature of the parents. No application will be entertained after the examination is over.
4. All concessions, stipends etc., are liable to be withdrawn if a student shows unsatisfactory results in the house examination.

### **LEAVE RULES**

1. Students should be regular in attendance and punctual in their classes.
2. Leave must be obtained from the Principal before it is availed of.
3. Leave for 3 days will be granted by the faculty in charge.
4. Leave for more than 3 days will be granted by the Principal on the recommendation of the faculty  
In charge.

**NOTE: - Total Leave to be availed by the student must not exceed 20% of the total lectures delivered during the session.**

### **WITHDRAWAL OF NAME FROM COLLEGE ROLL**

1. A student who wishes to withdraw his/her name from the college must submit his/her application in the college office duly signed by his/her parents as token of their consent for the same. Such applicant should be presented to the Principal in person after clearance of dues.
2. If a student does not get his/her name removed from the rolls of the college by giving an application to the Principal, he/she will be treated on rolls of the college for the purpose of realization of dues even for the period of absence from the college.
3. If the name of student is struck off from the rolls of the college after his/her admission form has been sent to University for non-payment of dues or any other reason, his/her admission form will be withdrawn by the Principal, No notice will be given to the student or his guardian.
4. The name of all such a students who fail to clear their dues may be absence fine alone at the proper time will be removed from the college rolls. No concession shall be allowed to players or top scholars in this respect.

## **LIBRARY RULES**

1. The library remains open from 9.00 a.m. to 4.00 p.m. with lunch break from 1.00 p.m. to 1.30 p.m.
2. Maximum two library books are issued to the students on the diary cum identity card for a period of 4 days after which these must be returned or re-issued if the same are not already in demand with the special permission of the librarian. A fine of Rs. 1.00 per volume per day will be charged if the books are kept overdue.
3. Loss of identity card cum diary should immediately be reported to the librarian so that librarian and library staff may keep an eye on the issue of books on the lost identity card cum diary.
4. If a student loses a library book issued to him/her, he/she will be required to pay its full price.
5. Reference books and current periodicals shall be not issued.
6. Library books should not be passed on to any guest and friends in library.
7. The students are required to possess their identity cards while inside the library. The defaulters will be asked to leave the library and their cases reported to the Principal.
8. Students are advised to observe perfect silence in the library cum reading room and not to disturb others in anyway.
9. Any kind of damage to library books in the form of scratching, over writing, tearing of the pages and spoiling of the books in any manner will render the borrower liable to exemplary fine and disciplinary action beside his/her responsibility of replacing book within 14 days failing which double price of book will be charged from him/her along with fine.

Scholarship forms complete in all respects i.e. attested/verified/certified by the competent authority along with attested copies of all certificates from academic qualification starting matric/Higher Secondary onwards/income/caste/tribes and Passport size photographs be submitted in the college office well in time.
